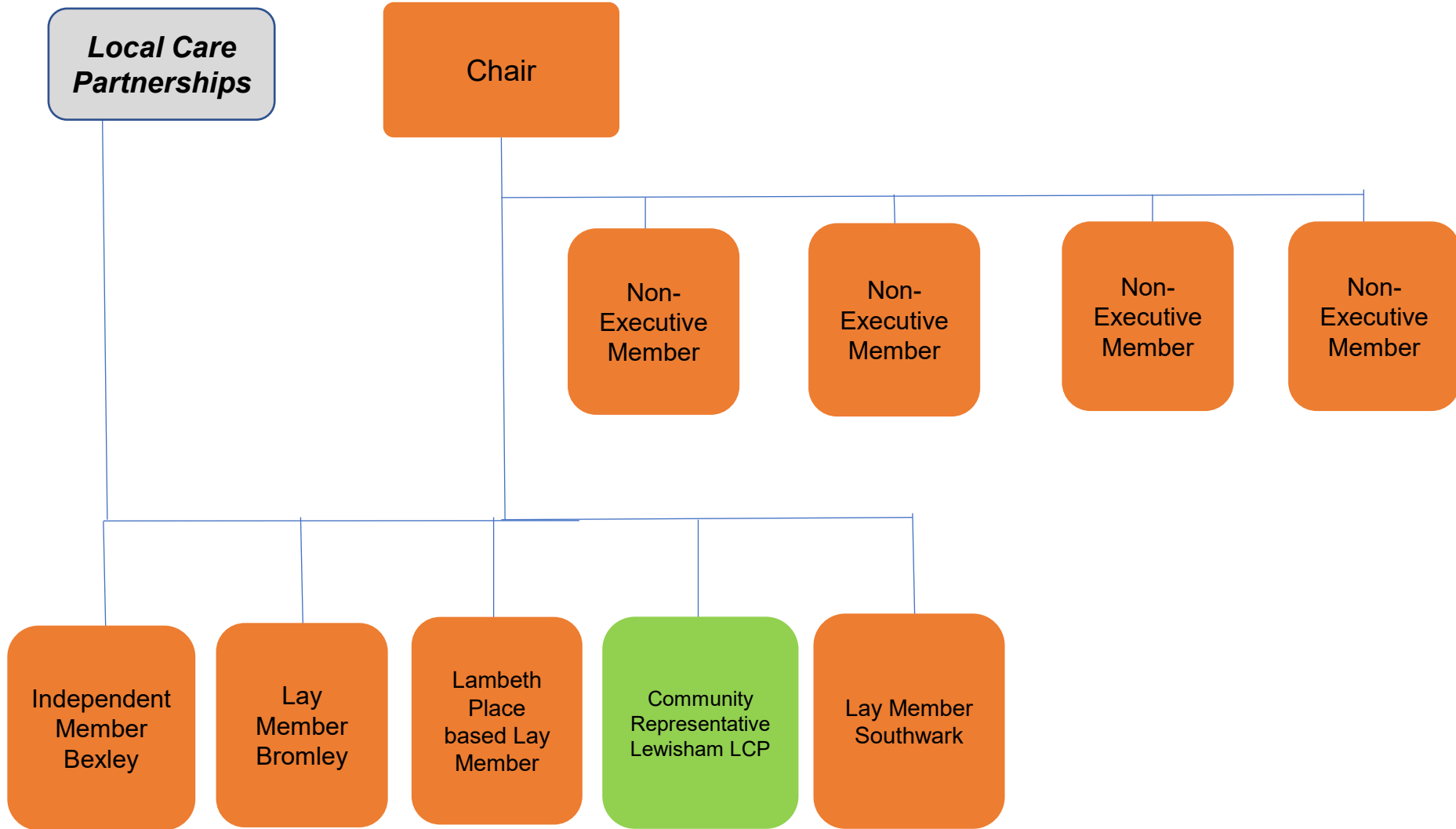

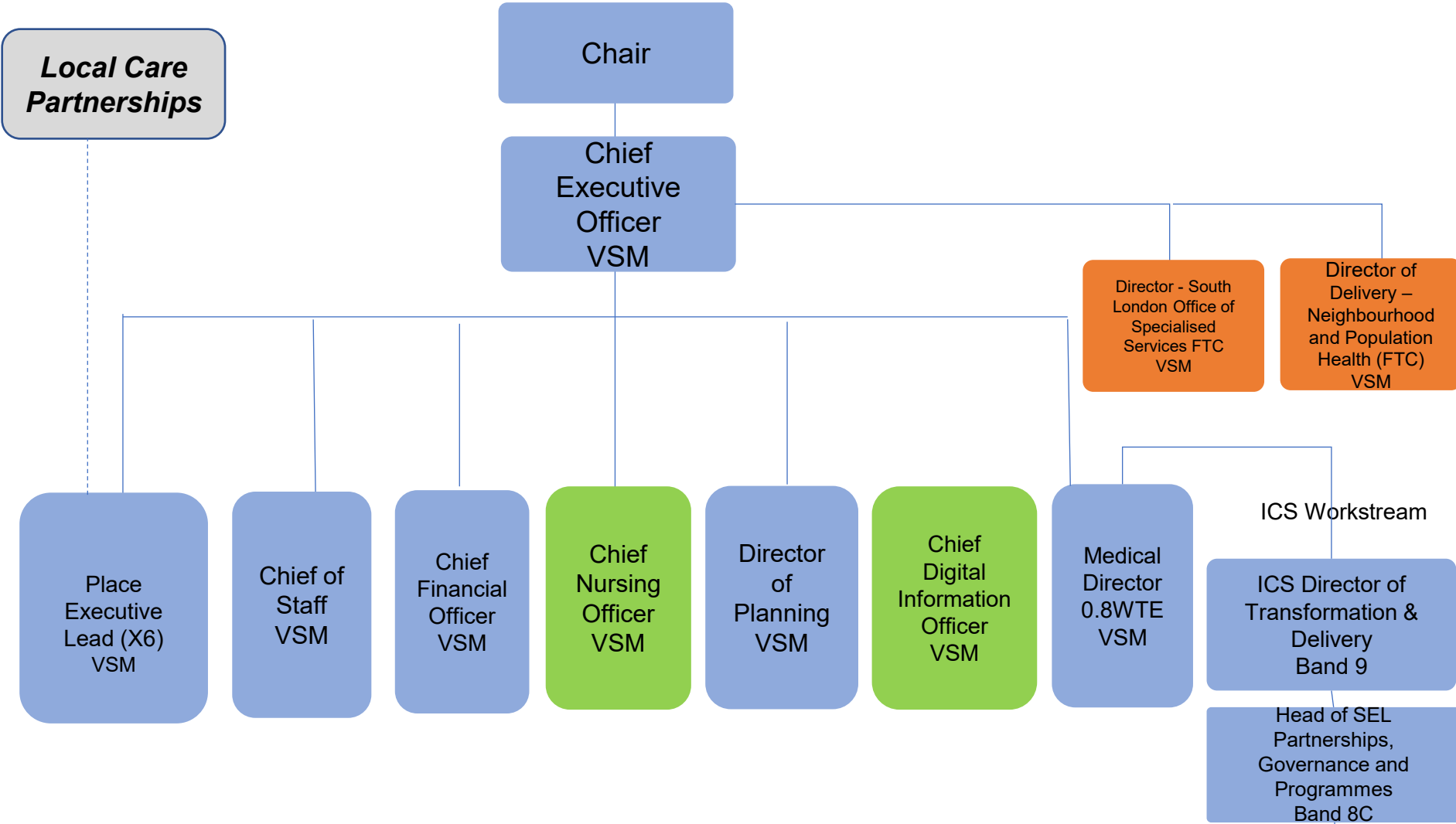

NHS South East London Executive Team Structure



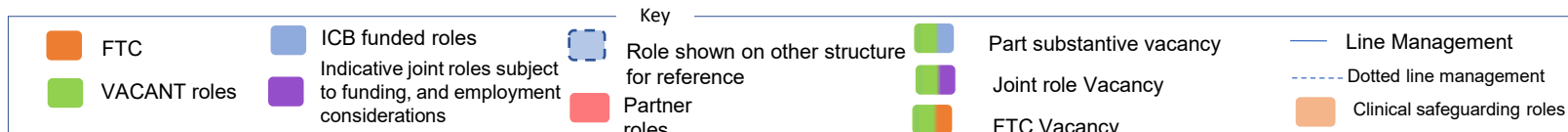
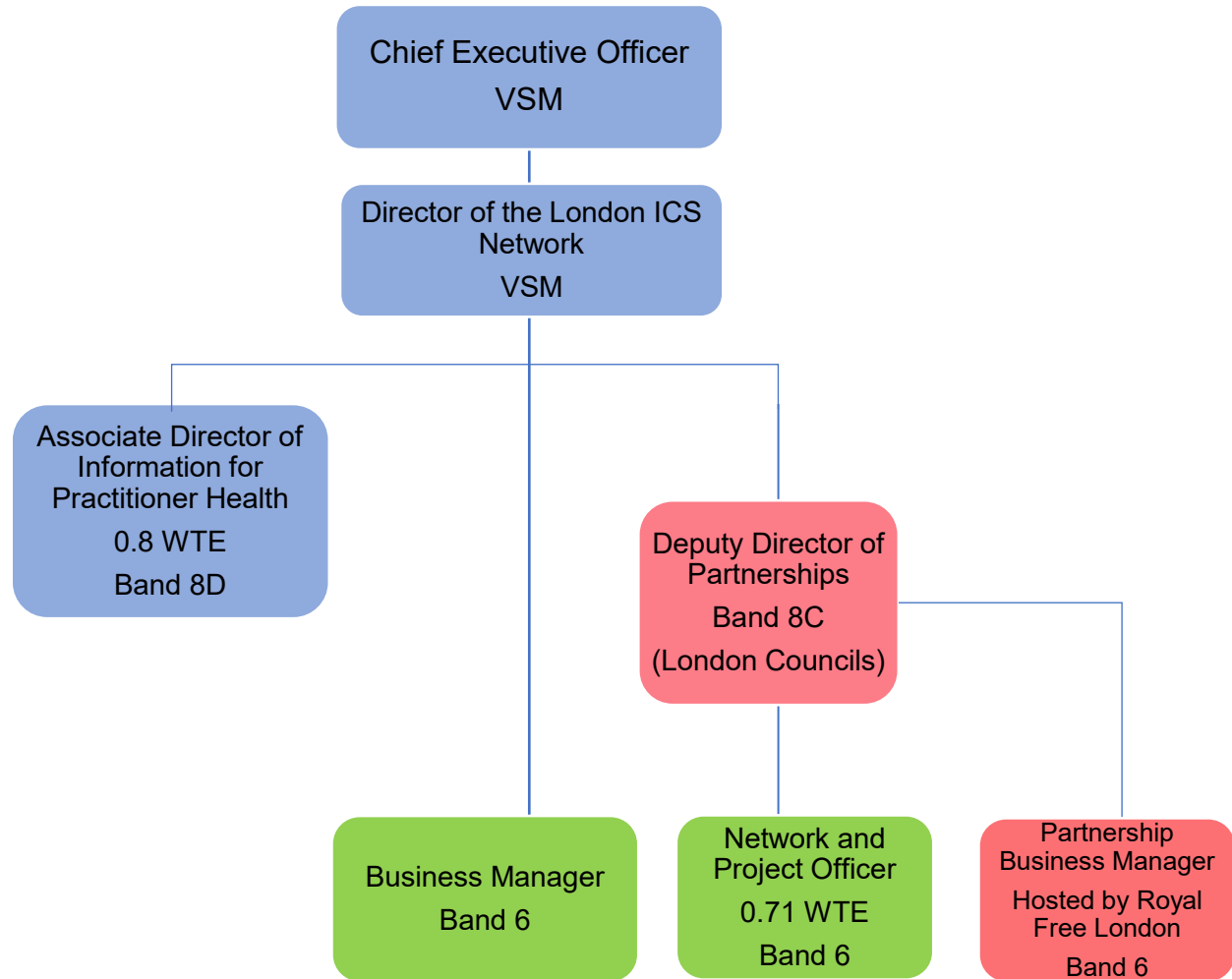

Estates Team Structure



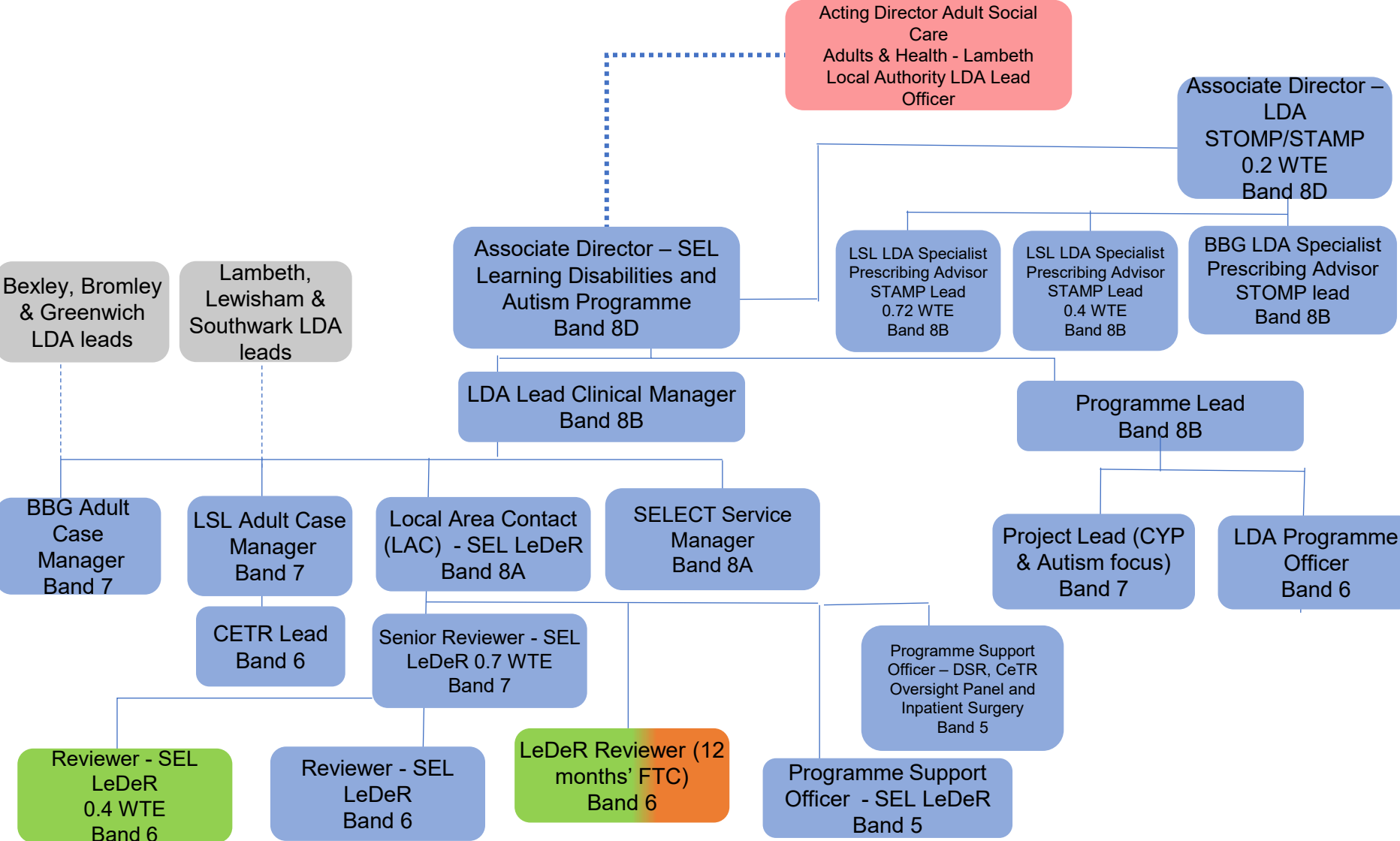

Medicines Optimisation Team Structure

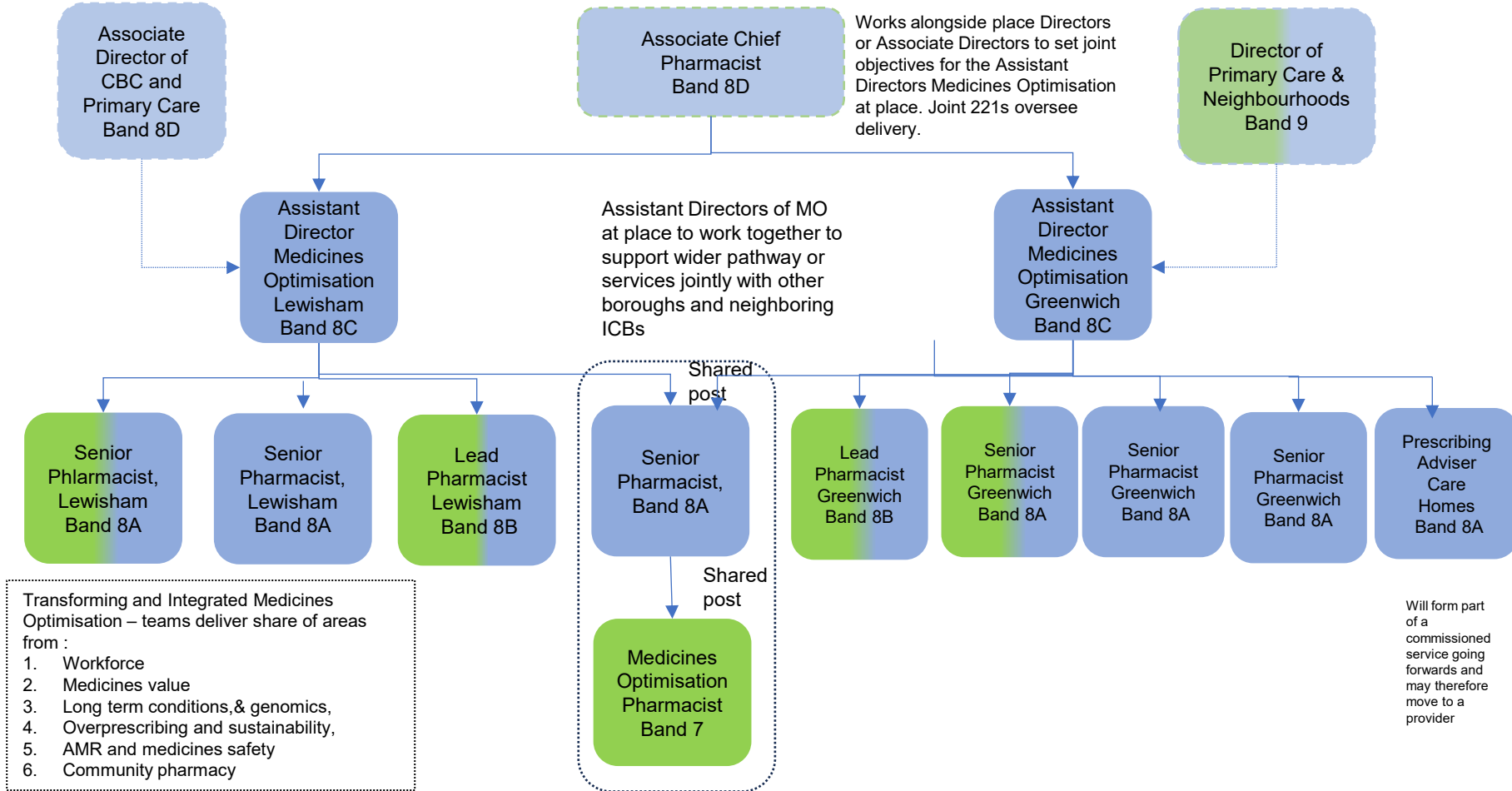

- Training, professional development





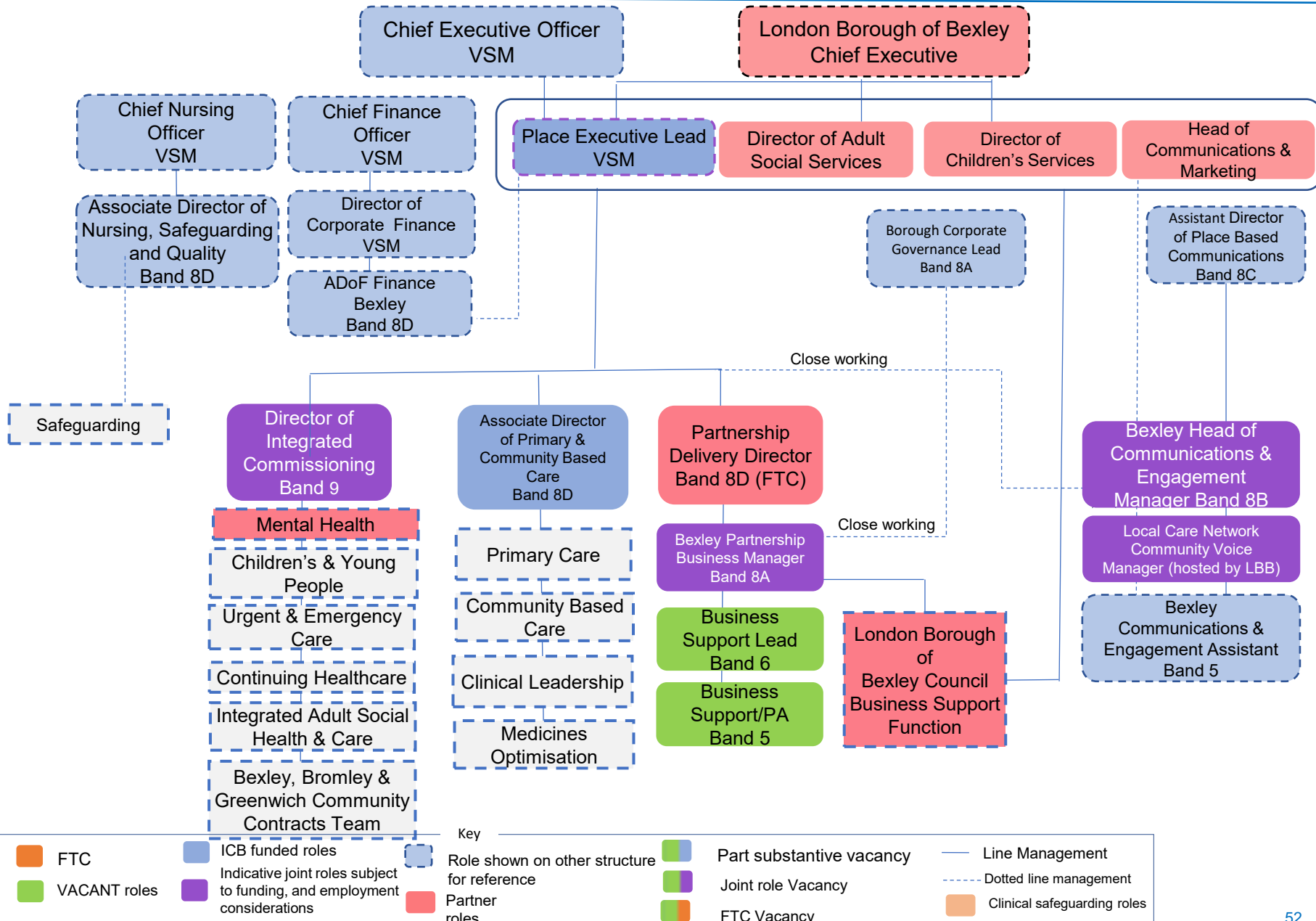
