

## **Lambeth Position Statement: Items Available Over the Counter for Self-Care**

The prescribing of items available over the counter (OTC) for self-care is NOT supported by NHS South East London Integrated Care Board (ICB) in line with [NHS England policy guidance: Conditions for which over the counter items should not be routinely prescribed in primary care](#).

Please refer to the [South East London Integrated Medicines Optimisation Committee Position Statement](#) for items available over the counter for self-care (PS-013) February 2019, for details of which OTC items are no longer prescribed for minor health conditions and exceptions to the guidance.

Additionally, in line with our local consultation on OTC items no longer for routine prescribing as NHS Lambeth Clinical Commissioning Group in July 2017, Lambeth does not support the routine prescribing of OTC items for the management of scabies and vaginal thrush.
