<b>Intervention:</b>	<b>Doxycycline 40mg modified release capsules (Efracea®) for the treatment of papulopustular facial rosacea in adults</b> (Doxycycline is a tetracycline based antibiotic)

<b>Recommendation</b>	<b>GREEN – can be prescribed within agreed criteria for use in primary or secondary care</b>
<b>Further Information:</b>	<ul style="list-style-type: none"> <li>• Doxycycline 40mg (formulated as modified release [M/R] capsules, Efracea®) is approved in SEL to reduce papulopustular lesions in adult patients with facial rosacea. This is the licensed indication for the product.</li> <li>• In line with the SEL <a href="#">Dermatology Guidelines for Primary Care</a>, doxycycline 40mg M/R is reserved as a <b>2<sup>nd</sup> line antibiotic</b> where there is intolerance (e.g. abdominal pain, nausea) to the first line oral antibiotic choice (doxycycline 100mg).</li> <li>• Please refer to the SEL <a href="#">Dermatology Guidelines for Primary Care</a> and <a href="#">Recommendation 083</a> for further information on treatment steps prior to oral antibiotic agents.</li> </ul> <p><b>Practical information</b> (refer also to <a href="#">SPC</a> and <a href="#">patient information leaflet</a> for further information):</p> <ul style="list-style-type: none"> <li>• Patients should be evaluated after 6 weeks and, if no effect is seen, consideration should be given to stopping treatment.</li> <li>• Where treatment is successful it may be continued for up to 16 weeks. In clinical trials, lesions tended to reappear at 4 weeks follow-up after discontinuation. Therefore, it is recommended that patients should be assessed 4 weeks after stopping treatment.</li> <li>• Patients should be advised to take the capsule in the morning, on an empty stomach, preferably at least one hour prior to or two hours after their meal.</li> <li>• The capsule should be taken with adequate amounts of water in order to reduce the risk of oesophageal irritation and ulceration.</li> <li>• Doxycycline 40mg M/R should not be used in patients with ocular manifestations of rosacea (such as ocular rosacea and/or blepharitis/meibomianitis) as there are limited efficacy and safety data in this population. If these manifestations appear during the course of the treatment, doxycycline 40mg M/R should be discontinued and the patient should be referred to an ophthalmologist.</li> </ul>
<b>Shared Care/Transfer of care document required:</b>	N/A
<b>Cost Impact for agreed patient group</b>	<ul style="list-style-type: none"> <li>• It is estimated that approximately 30 patients might be suitable for treatment with doxycycline 40mg M/R in SEL.</li> <li>• Treatment costs £21.71 for 56 tablets (1 month supply). Assuming a treatment course of 16 weeks in all patients at the licensed dose of 40mg daily and one treatment course a year, this would result in a cost of ~£2,600 across SEL (excluding VAT).</li> <li>• As doxycycline 40mg M/R may be initiated in primary care, this has the potential to release savings through reduced referrals to dermatology.</li> </ul>

<b>Usage Monitoring &amp; Impact Assessment</b>	<b>Acute Trusts:</b> <ul style="list-style-type: none"> <li>• Monitor usage and report back to SEL IMOC when requested.</li> <li>• Audit to ensure use in line with this recommendation and local pathway.</li> </ul>
	<b>SEL Borough Medicines Teams:</b> <ul style="list-style-type: none"> <li>• Monitor primary care prescribing data.</li> <li>• Audit locally to ensure use in line with this recommendation and local pathway.</li> <li>• Exception reports from GPs if inappropriate prescribing requests are made to primary care.</li> </ul>
