1. Scope and Introduction

The Provider Selection Regime requires each Relevant Authority to publish a summary of their application of the regulations. This paper outlines NHS South East London Integrated Care Board's (SEL ICB's) summary of all contracts awarded using the Provider Selection Regime (PSR) between 1st January 2024 and 31st March 2025. This is the first report of its kind since the inception of the PSR Regulations.

Summary of Representations

During the period of January 2024-March 2025, NHS SEL ICB received two Representations.

One case is still on-going with legal advice sought. The remaining case was handled in line with the PSR regulations, a local panel was convened to review the competitive procurement process which was carried out. The panel members concluded that the competitive procurement process had been carried out in line with PSR regulations and the decision was made to proceed to award the contract. A final standstill period was observed with no further representations made.

No Representations have been escalated to the Independent Patient Choice and Procurement Panel during the reporting period.

The ICB reflects on lessons learned from its procurement processes and in other sectors where representations have been observed and upheld. The NHS London Commercial Hub supports the ICB in digesting national case material and presenting to the Pan London Procurement Forum. This provides opportunity for shared learning, critical thinking and a place for reflection and inward sharing.

Compliance with PSR processes (timeliness in award, route to award, notice publication)	<p>Prior to the introduction of the Provider Selection Regime, SEL ICB nominated an implementation lead to work with the London Commercial Hub to ensure that internal processes were compliant with the new regime.</p> <p>The London Commercial Hub chaired weekly pan-London meetings identifying and tracking the actions required to become compliant.</p> <p>This included updating the ICB's Standing Financial Instructions (SFI's), Schedule of Matters Delegated to Officers and Procurement Policy. Existing Contract & Procurement Groups were also adapted to ensure compliance with the Provider Selection Regime.</p> <p>Whilst compliant with the majority of PSR processes, in undertaking this review the ICB has identified areas of non-compliance with regards to patient placements.</p> <p>In order to move towards compliance, the ICB is raising this as a risk on its Risk Register so there is visibility across the organisation and mitigations can be put in place/tracked to move towards full compliance.</p>
Decisions made under the PSR	Compliant with regulations. SEL ICB has a robust governance process in place that underpins the full procurement life cycle ensuring decisions are made in accordance with PSR and that these are documented.
Contract Modifications	SEL ICB's application of Contract Modifications are compliant with the Provider Selection Regime, with Transparency Notices published where Modifications are above £500k.
Declaration and Management of Conflicts of Interest	Compliant: There is a robust conflict of interest (COI) process in place within the ICB.
