



Medicines Optimisation Privacy Notice

Plain English Explanation

This Integrated Care Board has a Medicines Optimisation function to support patients and also help to deliver cost effective changes at GP Practices.

The processing takes place under two national Service Level Agreements, the National Tariff Excluded Drugs Service and the Home Oxygen Service.

Personal data is used for both care outcomes, monitoring and invoice reconciliation. The reports used by the Home Oxygen Service contain personal data, which has been consented for sharing upon patients initiation of treatment.

We collect and store information that has been received directly from the patient or from the following organisations; - *GP Practices, NHS Trusts, Providers and Care Homes.*

We may share information with the following organisations with your explicit consent or when the law allows: GP Practices or other Healthcare Providers and the London Fire and Rescue Services. https://www.nhs.uk/pages/home.aspx
