



## **Public Health Privacy Notice**

## **Plain English Explanation**

Public health encompasses everything from national smoking and alcohol policies, the management of epidemics such as flu, the control of large-scale infections such as TB and Hepatitis B to local outbreaks of food poisoning or Measles. Public Health England (PHE) monitors the numbers of certain infections that occur in healthcare settings through routine surveillance programmes and advises on how to prevent and control infection in establishments such as hospitals, care homes and schools. In order to allow PHE to carry out accurate monitoring of infections, it may rely on information held by the Integrated Care Board (ICB) with regards to Healthcare Acquired Infections (HCAIs).

This will necessarily mean the subjects personal and health information being shared with the Public Health organisations.

6) Your Individual Rights	Right to Object
	You have the right under Article 21 of the UK GDPR to object to your personal information being processed. Please contact the ICB if you wish to object to the processing of your data. You should be aware that this is a right to raise an objection, but this does not mean that the ICB will oblige your wishes in every circumstance.
	Right to Access and Correct Information
	You have the right to access any personal identifiable data that is being shared and to have any inaccuracies in recorded data corrected.
